The tender forms will be issued to the contractors/agencies/societies upto the date of opening of tenders as mentioned against work by 10.00AM and will be received upto 11.00AM in the office of the Principal and opened at 12.00Noon on the same day in the Principal's office in the presence of the tenderers or their authorised representatives, who may like to be present at that time. The tender documents may be obtained from the office of the undersigned and the same be deposited in the office of the Principal by the due date.

CONDITIONS

1. DNIT and drawings can be seen either in the office of undersigned on any working day during office hours (9.00AM to 2.30PM) or on the website, www.jatcollegerohtak.org.
2. In case, tendering day happens to be a holiday, the tenders will be received / opened on next working day at the same time.
3. Earnest money is to be deposited before purchase of tender. It should be in the shape of demand draft of any schedule bank in favour of the Principal, AI Jat HM College, Rohtak.
4. The contractors shall quote single percentage of rate below/above, HSR + CP as on Nov., 2011, for civil, PH and electrical works separately. NS item rates are to be quoted separately, otherwise tender will be rejected.
5. The contractors should bring self attested proof of enlistment in appropriate category with copy of PAN card and latest income tax return copy with them. They should also bring one successfully work done certificate of approximate same amount during the last two years.
6. Tender having conditional rebates shall be considered invalid and shall be outrightly rejected.
7. Any work, here tendered, may be withdrawn from further processing at any stage at the discretion of the competent authority without assigning any reason.
8. Nothing extra whatsoever shall be paid on account of losses, damages done by rains or any other natural calamity.
9. The tender will be outrightly rejected if the tender is found either in variance of the above conditions or the conditions of the DNIT.
10. The contractors/agencies/societies shall paste the cellotape on the rates quoted by them.
11. The building committee of the college reserves the right to accept or reject or negotiate any of the tender or conditions/items without assigning any reason thereof.

12. The building committee of the college is competent to increase/decrease the quantity of the work.
13. The tenderers are advised to visit the site sufficiently in advance to the date fixed for submission of the tender. A tenderer shall be deemed to have full knowledge of all the relevant documents, samples, sites etc. whether he/she inspects them or not.
14. 10% security will be deducted from the running bills subjected to the maximum of 5% of the estimated cost and it will be refunded as under:
 - a. 75% of the security deducted will be refunded after three months of the completion of the project.
 - b. Balance 25% will be refunded after one year of completion of work subjected the clearance of final bill before the release of the security.
15. The taxes will be deducted from the bills of the contractors as per Govt. rules amended from time to time.
16. The defects liability period will be one year after completion of the project.
