## CONDITIONS:

- 1) DNIT and drawings can be seen either in the office of undersigned on any working day during office hours (9.00AM to 3.00PM).
- 2) In case, tendering day happens to be a holiday, the tenders will be received / opened on next working day at the same time.
- 3) Earnest money is to be deposited before purchase of tender. It should be in the shape of demand draft of any scheduled/nationalized bank in favour of the Principal, AI Jat HM College, Rohtak. Online payment of EMD is acceptable is college website too.
- 4) The contractors shall quote single percentage of rate below/above, HSR as on 30/11/2023, for civil works, Public Health and Electrical Works. NS item rates are to be quoted separately, otherwise tender will be rejected. GST will be paid extra as per norms.
- 5) The other extra items beyond DNIT if required at site will be got executed as per the specifications of HRS 2020-21 only. However, any other NS items beyond DNIT will be got executed after approval of competent authority.

- 6) The contractors should bring self attested proof of enlistment in appropriate category with copy of PAN card and latest income tax return copy with them. They should also bring one successfully work done certificate of approximate same or higher amount during the last two years.
- 7) Tender having conditional rebates shall be considered invalid and shall be outrightly rejected.
- 8) Any work, here tendered, may be withdrawn from further processing at any stage at the discretion of the competent authority without assigning any reason.
- 9) Nothing extra whatsoever shall be paid on account of losses, damages done by rains or any other natural calamity.
- 10) The tender will be outrightly rejected if the tender is found either in variance of the above conditions or the conditions of the DNIT.
- 11) The contractors/agencies/societies shall paste the cello tape on the rates quoted by them.
- 12) The repair committee/s of the college reserves the right to accept or reject or negotiate any of the tender or conditions/items without assigning any reason thereof.
- 13) The repair committee/s of the college is competent to increase/decrease the scope of the work depending upon the site conditions/requirements at the same rate with same terms and conditions.
- 14) The tenderers are advised to visit the site sufficiently in advance to the date fixed for submission of the tender. A tenderer shall be deemed to have full knowledge of all the relevant documents, samples, sites etc. whether he/she inspects them or not.
- 15) 10% security will be deducted from the running bills and as well as in final bill it will be refunded as under:

Earnest money will be adjusted in the 10% security deposit.

- a) 75% of the security deducted will be refunded after three months of the completion of the project.
- b) Balance 25% will be refunded after one year of completion of work subject to the clearance of final bill before the release of the security and satisfaction of work.
- 16) All type of taxes will be deducted from the bills of the contractors as per Govt. rules amended from time to time.
- 17) The defects liability period will be one year after completion of the project.
- 18) The notice inviting tender and amendments, if any, can be seen at the website of the college, www.jatcollegerohtak.ac.in.
- 19) The contractor is required to complete the entire work well in time otherwise he is liable for penalty, however extension in time limit may be granted by the competent authority on reasonable grounds with a prior request before due date of completion of the work.
